Applications are invited from the eligible candidates in the prescribed proforma for the post of Director, Veer Surendra Sai Institute of Medical Sciences and Research, Burla, Sambalpur, Odisha in the scale of pay of Rs.37,400 - 67,000/- + AGP of Rs. 10,000/- or (as admissible from time to time) + Special Allowance of Rs.5,000/- per month.
