Persons entitled to vote and stand for election: All persons whose names are borne on the Odisha Medical Council and who possess the medical qualifications included in the First or the Second Schedule or in part II of the Third schedule of the Indian Medical Council Act, 1956 shall be entitled to vote at the election of member under Section 3(1)(c) and to stand as candidates for such election. If any question arises as to whether a person is or is not entitled to vote in the election or to stand for the election, the decision in such case(s) of the Returning Officer shall be final.

Note :

1. Nomination Form, signed voting paper, declaration paper & letter of intimation are available at the Website of www.dmetodisha.gov.in of Odisha.
2. The nomination forms shall be received in the office of the undersigned.
3. The last date and time of receipt of nomination forms shall be 09.10.2013 till 3.00P.M.

4. Each nomination paper shall be subscribed by two electors as proposer and seconder, provided that no elector shall subscribe more nominations than one, and further provided that if more than one nomination paper be subscribed by the same elector, the nomination paper first received by the Returning Officer shall, if otherwise in order, be held to be valid and if more than one nomination paper signed by the same elector be received simultaneously by the Returning Officer, all such nomination papers shall be held to be invalid.
5. The prospective candidate or their duly authorized representative may attend the process of scrutiny of nomination papers and counting of votes.
