1. GENERAL INFORMATION:

1.1 Selection for admission into first year of 2 years 3 months Diploma in Pharmacy course in the Government & Private Pharmacy Colleges of the State of Odisha, approved by Pharmacy Council of India (except Women's Polytechnics, Bhubaneswar) will be conducted by the D.Pharm. Selection Committee-2014-15 (herein after called Committee) until otherwise directed by the Government.

Admission to all the seats in the Pharmacy Wing, S.C.B.Medical College and 85% of total seats of all the Private Pharmacy Colleges, listed prepage, will be done by the Convener through counselling. Rest 15% of the seats of the Private Pharmacy Colleges will be Management quota & would be filled up by the respective management along with surplus seats left over after the Government counselling with due consideration to the Prospectus.

2.2. RESERVATION OF SEATS:

The reservations of seats will be as follows:

8% seats are reserved for Scheduled Castes, (SC) [by birth only and not by marriage or adoption],

12% seats are reserved for Scheduled Tribes (ST) [by birth only and not by marriage or adoption],

3% seats are reserved for Physically Challenged (PH) candidates with at least 40% disability,

5% seats are reserved for children of Green Card holders (GC),

3% seats are reserved for children of Ex-Servicemen and defence personnel (DF)

15% seats in Private Pharmacy Colleges would be Management quota.

Scheduled Caste/Tribe persons who have migrated from their State of Origin to some other State for the purpose of seeking education, employment etc. will be deemed to be Scheduled Caste/Tribe of the State of their origin and will be entitled to derive benefits from the State of origin and not from the State to which they have migrated. (Vide Govt. of Indian letter No.BC/16014.1.82-SC & BCD/dated 22nd Feb.1985.)

In Government Counselling, in case of non-availability of candidates belonging to S.C. category, S.T. candidates can be selected subject to other eligibility conditions and vice versa. In case of non-availability of candidates of SC/ST/PH/GC/DF categories, the unfilled seats will be filled up by the unreserved candidates.

The Management quota seats as well as seats remaining vacant in Private Colleges, after Government Counselling would be filled up by the management of the college concerned considering the eligibility criteria prescribed in the Prospectus in accordance to merit of the candidate.

3. PROSPECTUS AND APPLICATION FORM

Website Application form and prospectus be downloaded from the can http://www.dmetorissa.gov.in (Click on PHARMACY) or be obtained personally from the Office of the Convener, D.Pharm. Selection Committee 2014-15, Pharmacy Wing, S.C.B. Medical College, Cuttack - 753007 from 18.08.2014 to **06.09.2014.** There is no provision of sending blank application form through post. The last date of submission (Receipt) of completed form is 6th September 2014 (5-00 P.M.).

4. ELIGIBILITY FOR APPLICATION

To be eligible to apply for D.Pharm. Course the applicant must -

- 4.1 Have passed 10 + 2 Science (Academic Stream with Practicals) examination with Physics, Chemistry, Biology (Bio-science/Life-science) and/or Mathematics from C.H.S.E., Odisha or any examination equivalent to it, approved by Pharmacy Council of India (Student of Vocational course/Open University & distance education/correspondence course are not eligible). For list of approved examinations see **APPENDIX I**.
- 4.2 Be in between 17 to 28 years of age on 31.12.2014. <u>i.e.</u> born on or after 01.01.1987 but on or before 31.12.1997. However the upper age can be relaxed up to 5 years for candidates belonging to P.H./S.C./S.T./O.B.C./S.E.B.C. categories of candidates. Further the upper age limit is not applicable for Management quota of Private Pharmacy Colleges including surplus seats left over after Government Counselling.
- 4.3.1.Be a Native/Permanent Resident of Odisha **OR** son, daughter or spouse of permanent resident of Odisha as defined in Govt. of Odisha in Home Department Resolution No.38/reforms, dated 18.1.1949. Such candidates shall furnish certificate of Nativity/Permanent Residentship of Odisha from the Tahasildar of the areas concerned. If somebody is not a native of Odisha but residing in Odisha then his/her period of residency must be mentioned on the certificate.

OR

4.3.2.Son, daughter or spouses of :

- i) Employee of Govt. of Odisha.
- ii) Defence Personnel posted in Odisha/Employee of Govt. of India working in Odisha.
- iii) Member of All India Services (Odisha Cadre) serving within/outside Odisha.
- iv) Employee of Govt. of India Undertaking/Govt. of Odisha Undertaking located in Odisha.

Such claims should be supported by certificate of service of parents or spouse from competent Authority.

OR

4.3.3.Odia belonging to outlying Odia speaking tracts (as defined by Government of Odisha, P. & S. Dept., Resolution No.13411 Gen. dated 8.8.69, as amended from time to time), the candidates must have Odia as M.I.L in H.S.C. or equivalent examination. Such candidates shall furnish the certificate of authenticity of their domicile from an officer not below the rank of S.D.O. (Civil) of the locality and H.S.C. certificate showing Odia as M.I.L.

OR

4.3.4. An Indian National (including NRI) other than 4.3.1. to 4.3.3. mentioned above. But such candidates would be eligible for admission into Private Colleges only & not Government College. Further their case would be considered after all candidates belonging to clause 4.3.1 to 4.3.3 are exhausted.

5. SUBMISSION OF APPLICATION

- 5.1 The candidates seeking admission into D.Pharm. course are to apply the "Convenor, D.Pharm. Selection Committee, Pharmacy wing, S.C.B.Medical College, Cuttack-753007" in the prescribed form as described in clause 3 above, along with required documents as per clause 6 below & a Bank Draft of ₹ 600/- drawn in favour of "Convener, D.Pharm. Selection Committee", payable at Cuttack.
- 5.2 It is the responsibility of the Candidate to see that his/her Application form, completed in all respect along with all required documents, reaches the office of the Convener, latest by 5-00 P.M. of the last date <u>i.e.</u>, 06.09.2014.
- 5.3 The office of the Convener shall have no responsibility for application(s) reaching late for any reason including postal delay. Such applications shall be summarily rejected and no correspondence in this regard shall be made nor any representation in this regard shall be entertained.
- 5.4 Application form must be filled in by the candidate's own handwriting and correction made, if any, must be legibly initialled by the candidates.
- 5.5 Applications those are incomplete, illegible, incorrectly filled up or not accompanied by essential documents shall be summarily rejected.

6. DOCUMENTS TO BE FURNISHED ALONG WITH APPLICATION.

Clear photocopy of the following documents, self-attested with full signature of the candidate should be attached to the application form. Backside contents, if any, are to be Photocopied too.

- (i) Pass certificate of H.S.C. or equivalent examination with M.I.L. and date of birth of candidate recorded therein (if the D.O.B./subjects are not written in the H.S.Certificate but appears on the Admit Card/Mark-sheet then the same is to be enclosed). Other certificates of age such as Certificate from Headmaster/Principal of the School/College, birth certificate from hospital or municipality etc. are not acceptable.
- (ii) Pass certificate of the qualifying examination showing the subjects studied.
- (iii) Mark-list of the qualifying examination.
- (iv) Conduct certificate from the Principal of the College last studied/gazetted officer (issued within last 6 months).
- (v) Caste/Tribe Certificate from the Revenue Officer not below the rank of Tahasildar of the area to which the candidate belongs in case of applicant belonging to S.C./S.T. category. The name of the Caste/Tribe must appear in the Certificate and Schedule of Caste/Tribe of the Odisha (for S.C./S.T.) Rules, 1980.
- (vi) Physically Handicapped certificate issued by the Social Welfare/Panchayat Raj Department, Government of Odisha/District Social Welfare Officer in case of candidate claiming seat reserved for Physically Challenged (PH) candidates. (Certificate issued by Chief District Medical Officers will not be entertained).
- (vii) Green Card in the prescribed form from the Chief District Medical Officer of the concerned District in case of candidate claiming the seat reserved for children of "Green Card Holders". The name, father's name & date of birth of the beneficiary must have been mentioned clearly on this certificate and should tally with the

- date mentioned in the High School certificate. This facility of the green card must not have been used more than once before.
- (viii) Certificate in the prescribed form from the Station Commander/Officer Commanding/Office-in-charge, Zilla/Rajya Sainik Board in case of candidate claiming seats reserved for children of Ex-servicemen/Defence personnel.
- (ix) Residential/Nativity Certificate from Tahasildar, issued within one year.
- OR Service Certificate of parent/spouse.
- (x) O.B.C./S.E.B.C. Certificate issued within 3 months by the Revenue Officer not below the rank of Tahasildar of the area; for candidates claiming age relaxation in this category.
- (xi) The Bank draft for ₹ 600/- in original.
- (xii) A self addressed stamped (₹ 22/-) envelop (Apx. Size 10 cm X 24 cm) with the correct postal address for correspondence written clearly on it.
- (xiii) One copy of recent pass-port size photograph taken against a light background, on or after **01.04.2014**, indicating the name of candidate & date taken. It must be firmly pasted at the place prescribed in the application form & duly attested on the front side by a Group 'A' or Group 'B' Officer with seal. The signature and the official stamp on the photograph should be placed in such a way that these extend in part to the application form. Photographs attested at the back side or loosely stapled or old will not be accepted.

7. **SELECTION**

- 7.1. Selection for admission shall be made on the basis of merit judged according to aggregate marks secured in Physics, Chemistry and Biology or Mathematics (whichever is more) in the qualifying examination. 1% mark shall be deducted from the percentage of this aggregate for each failure or dropping at the qualifying examination. (However appearing in instant examination would not liable for deduction of marks).
- 7.2.1.In case of candidates having equal marks in aggregate of Physics, Chemistry and Biology or Mathematics (whichever is more) in the qualifying examination *inter se* merit shall be decided as follows:
- 7.2.2. According to the Grand total marks (with extra optional) secured at the qualifying examination in the first attempt. In case of further tie;
- 7.2.3. According to the marks secured in biology at the qualifying examination. In case of further tie;
- 7.2.4. According to the marks secured in Chemistry at the qualifying examination.
- 7.3 The merit list of the candidates shall be published in the Notice boards of the Office of the Convener, and in website http://www.dmetorissa.gov.in on 09.09.2014. Objection to the merit list can be pointed out to the Convener personally/ telephonically (Mobile No. 0 91325 11331 or 0 92384 11331) or through E-mail (pwscbmc@hotmail.com) up to 11.09.2014 5-00 P.M.

- 7.4. Allotment of seats to candidates shall be made by the Committee in the Office of the Convener, Pharmacy wing, S.C.B. Medical College, Cuttack, through counselling, <u>i.e.</u> personal appearance, taking into account the candidate's eligibility, merit and preference for institution, subject to availability. The candidate, who fails to report personally for the Counselling in the stipulated time, will forfeit the claim for a seat.
- 7.5. For personal appearance, the candidate will be intimated by registered post in the self addressed envelope provided for correspondence and will be called in batches in order of merit as per the schedule of the counselling from **18.09.2014** to **20.09.2014**. Failure to appear personally for the counselling with all original documents in the specific date and time will liable for rejection of one's candidature. No extension of time would be allowed for personal appearance or submission of documents. Candidate, whose name appear in the merit list but do not get the intimation letter, can also attend the Counselling. They may contact the Convener personally/ telephonically (0 91325 11331 or 0 92384 11331) on **17.09.2014**. The counselling will stop automatically, once all the seats are filled up or all the candidates are exhausted.
- 7.6. After selection of candidates through counselling, the management quota as well as any vacancy still remaining can be filled up by the concerned College management on or before 30.09.2014. However such candidates must fulfil the criteria prescribed in the Prospectus. Further they are to be produced before the Convener along with all their original documents including two Affidavits as described below, Migration certificate & C.L.C. as well as a verification fee of ₹300/- per candidate in a suitable date latest by 14.10.2014.

8. ADMISSION:

Option once exercised in Counselling table is final & binding and no change would be allowed later. Such candidate would be allowed time up to **27.09.2014** to deposit the fee along with College Leaving Certificate/Transfer Certificate & Migration certificate in original in respective College, failing which the admission shall be cancelled. The admission can also be cancelled, if found subsequently, to have been made on false data or suppression of facts. The admission is subject to submission of declaration by the candidate and the Guardian that they would not be involved in ragging. No extension of time would be allowed for deposition of all these testimonials. However time up to **25.04.2015** may be granted for submission of Migration certificate only, in deserving cases. The seat thus fall vacant can be filled up by the College Authority within **30.09.2014**.

10. REGISTRATION UNDER BOARD:

All the candidates thus admitted are required to be registered under the Odisha State Board of Pharmacy within **15.10.2014** by paying the prescribed fee, Migration certificate in Original & copies of other required documents. No extension of time would be allowed by the Board except for submission of Migration Certificate in deserving cases.

11. PROHIBITION OF RAGGING IN EDUCATIONAL INSTITUTION:

Ragging is totally banned & prohibited in all the D.Pharm. institutions. Anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished including Cancellation of admission, Expulsion/Rustication from the College with debarring from admission to any other College and fine ranging from ₹ 25,000/- to ₹ 1,00,000/-. All students & their Guardian are required to go through "Regulations on curbing the menace of Ragging in Educational Institutions" (Appendix − II / available in website http://pci.nic.in/PDF-Files/Menace-of-Ragging-new.pdf), framed by Pharmacy Council of India as per the guidelines of the Hon'ble Apex Court & give Undertakings as per the Regulation to the College admitted.

MISCELLANEOUS:

- 12. A candidate who has been convicted of any criminal offence involving moral turpitude shall not be selected/admitted even though he/she may be otherwise eligible. In the event of concealment or misrepresentation of facts in this regard the admission shall be cancelled.
- **13.** After admission a candidate must abide by the Rules (including Hostel Rules) prescribed by the concerned College.
- **14.** In all matters relating to eligibility or otherwise of a candidate for registration, selection and admission to D.Pharm. Course; the decision of the Committee shall be final and binding.
