## GENERAL TERMS AND CONDITIONS FOR AUCTION SALE OF CONDEMNED ARTICLES

1. The interested tenderers may inspect the condemned articles available in the different department from the SCB Dental College & Hospital, Cuttack during working days from 04.04.2017 to 18.04.2017 on 11.00 AM to 5.00 PM for any clarification they may contact to the office of the undersigned before submission of tender.
2. The interested parties may inspect the old Instruments and equipments available in the different department of SCB Dental College & Hospital , Cuttack during working days from 04.04.2017 on 11 .00 AM to 5 P.M. For any clarification they may contact HOD / I/C of concern department / at Office of the Principal, SCB Dental College and Hospital, Cuttack. before submission of quotation.
3. Sealed Quotation should superscribed on the envelop "Quotation for Auction of Scarp materials "should reach the undersigned on or before 5 . 00 P.M. on Dt 20.04.2017 through Speed Post / Regd. Post only which will be opened on the next working day at 11 A.M. in presence of the questioners or their authorized representatives. There is no bar for opening of the Bid documents if the tenderer fails to present at the time of opening.
4. The quotationer should enclose Bank Draft @ Rs 10,000/- in favour of the Principal SCB Dental, College and Hospital, Cuttack drawn from any Nationalized bank at Cuttack towards EMD (non-interest bearing) along with their tender , without which the tender will be rejected.
5. The successful bidder will deposit Rs.30,000/- as advance money within seven days from receipt of the order. The condemned articles shall be handed over to the successful tenderer only after receipt of it's full value within the stipulated period as per the tender conditions.
6. The Condemned articles shall be handed over to the successful quotationer only after receipt of its full value within the stipulated period as per the tender condition.
7. The successful bidder will deposit 25% of the total value immediately on the spot. Otherwise his / her tender will be cancelled and EMD submitted by him/ her will be forfeited. The successful bidder will lift the items within seven days from finalization of the tender. The custody and safety of the Instrument and Equipments shall be the responsibility of the bidder after it is finalised receipt of the order, otherwise 1% of the total value will be charged for each day or part of the day till the condemned articles are removed from the site.
8. The EMD of all unsuccessful quotationer will be refunded after finalization of the quotation.
9. The EMD may be forfeited
  - a) If a quotationer withdraws its quotation during the period of interval between deadline of submission & finalization of the quotation.
  - b) In case of a successful quotationer , if the quotation fails to execute the work order.
10. The condemned articles will be handed over to the successful bidder after proper receipt of the deal at the places where it is lying. It will be the responsibility of the successful quotationer / purchaser to dismantled and take delivery of the condemned articles to their destination by their own arrangement.

11. The quotationer should sign and put his seal on each page of the quotation document i.e. Up to date VAT Clearance Certificate / PAN Card / Voter I.D. Card and submit the entire set along with the required amount of EMD in a sealed envelope.
12. Incomplete quotation shall be rejected.
13. Conditional quotation shall not be accepted.
14. The Principal SCB Dental College & Hospital, Cuttack reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
15. In case of dispute on any matter, the interpretation & discussion of the authority shall be final and binding and the legal procedures, if any, should be in the jurisdiction of the court of the Cuttack District only.
